## 9. Brief summary of the mission

The objective of this mission was to work with national and international consultants, working on PAMs prioritization and REDD+ fund management for quality assurance.

## **10. Findings**

## **REDD+ fund management**

- Held intensive discussion sessions with the international and national consultants on the finance work to agree on the scope and scale of work, specific deliverables and timeline of the deliverables.
- Discussed a number of directions towards which REDD+ finance work can explore in terms of how REDD+ can be framed and situated within Sri Lanka's overall governance structure.
- Agreed that the consultant team will identify and assess several viable options and through a stakeholder consultation select the most suitable option for which an implementation plan will then be developed.
- Discussed how this work stream should also consider the outcome of PAMs prioritization.
- Identified a key challenge to be the current uncertainly regarding REDD+ finance globally and lack of donor support/interest in this area in Sri Lanka.

## PAMs Prioritisation

- Agreed to amend the traditional MCA methodology to accommodate the context specific and perception-based nature of the current PAMs debate both the criteria identification and scoring of PAMs will be done by a wide range of national and sub-national stakeholders, while at the same time expert scoring will be done to supplement and compare against the stakeholder-led periodization outcome.
- Agreed that MCA criteria, which follow the Cancun safeguards, will be used for setting indicators for monitoring safeguards and PAM implementation performance.
- Recognised that stakeholders needed more time to identify criteria as they could be politically sensitive matters, and a wider range of stakeholders needed to be involved in this exercise, especially those from communities and IPs, based on the recommendations from the representatives of the CSO Platform.
- Agreed to reach out to a wider range of stakeholders and give an adequate review and feedback timeframe for the review of the list of PAMs and identification of criteria.
- Identified a need for providing a public information session at the start of this work stream to increase stakeholders' buy-in and reduce the risk of misunderstandings, confusions and contentions. Case in point, the MCA workshop was largely misunderstood by many people since the explanation regarding the whole prioritization exercise beyond the MCA was neither fully described nor understood.

**Others** 

- Work on GRM seemed to be missing an assessment/overview of the formal policing and judiciary systems. For instance, there is environmental police at the district level, but this mechanism was not accounted for. Therefore, a more balanced assessment of the existing mechanisms, their current capacities, functions and capacity gaps is still needed.
- GRM work should be aligned closely with the work on PAMs and finance to identify some key areas of contentions and how those would be best addressed.
- FD is already working with the private sector to release pieces of degraded forest or abandoned land for restoration and reforestation.
- General population of Sri Lanka do not wish to engage in tree planning and other labour activities, and often some migrant workers are brought in for those activities.
- Ban on export of medicinal and cosmetic products from forests has been lifted there is an increased interest in implementing effective forest and forest resources management.
- Professor Buddhi's original ToR were split into two the PLR review work will be handled by someone else.
