9. Brief summary of the mission

#### 9.a Background

The regional IP organisation, Asia Indigenous Peoples Pact (AIPP), has been coordinating a regional climate change partnership with IP (network) since 2009. Partners are based in Cambodia, Indonesia, Myanmar, Nepal, Thailand and Viet Nam, and activities have focused on capacity building, advocacy, developing and translating IP-related knowledge materials, and direct support to communities through testing various technical and participatory approaches. However, the Network is expected to complete its activities by March 2016, and new funding from NORAD will only focus on Myanmar and Viet Nam. AIPP is actively working with other donors to continue providing support to other network members.

The regional meeting of climate change partnership with IP from 2 to 6 February in Chiang Mai sought

- To get country updates on key issues; achievements; and lessons learned from the implementation of the project
- To identify key challenges and issues; and formulate steps forward
- To share the findings of the case studies on REDD+ Trust Fund in Nepal and Payment for Environmental Service (PES) in Vietnam
- To share the experiences of the UN REDD Programme on safeguards and orient participants on the UN REDD Programme Grievance Redress Mechanisms
- Review experiences of the AIPP and UN-REDD Programme's collaboration in Bangladesh, Myanmar and Viet Nam

#### 9.b Main Findings

a) Development of safeguards and SIS vary across different countries, but the common thread is that is generally an isolated event, not integrated with clear and cohesive national objectives.

Referring to the safeguards standard that the Forest Department had developed, Promotion of Indigenous and Nature Together (POINT) (Myanmar) had checked its implementation with communities, who remained unaware of its existence. Concerns were raised regarding the institutional arrangements required for a functional SiS, and how communities could be involved in its design and operation. It was clarified that once potential PaMs have been identified, the standard, although a good starting point, will be reviewed, primarily through the Technical Working Group (TWG) on Stakeholder Engagement and Safeguards. The Indigenous Peoples Foundation for Education and Environment (IPF) (Thailand) stated that the Thai government intends to establish a TWG on safeguards, but doubts its willingness to broaden the scope of safeguards, although noting that this may not inspire investors' confidence to provide results-based payments. The Nepal Federation for Indigenous Nationalities (NEFIN) (Nepal) shared that the government placed greater priorities on FCPF's SESA and ESMF requirements since it is a recipient of the Carbon Fund. Since the SESA and ESMF may not encompass the reach of those proposed by UNFCCC's Cancun safeguards, NEFIN requested the Programme to discuss the possibility

of a Targeted Support (TS) on safeguards with its government. However, it was clarified bilaterally with NEFIN that the Programme will not be able to provide any TS in 2016.

# b) Support to effectively operationalise the information flow and feedback mechanism between national and sub-national IP representatives should continue.

The Cambodian Indigenous Youth Association (CIYA) (Cambodia) informally shared that the IP representative in the PEB, Mr Man Pak, has requested their assistance in fulfilling his role. To date, he has not been in frequent touch with the other provincial IP representatives and there has been some discontent among members. There is supposedly a request from Cambodia's REDD+ Taskforce Secretariat (RTS) for Mr Man Pak to outline the types of support he needs, as well as costs involved. This needs to be double-checked with the RTS, as well as clarify if and how the information flow and feedback mechanism between national and sub-national representatives, decided during the consultation of the draft national REDD+ strategy (NRS), has been operationalised. With the impending development of an Action Plan based on the NRS, it is crucial that Mr Man Pak is able to fulfil his roles and responsibilities. Additionally, the IP representative in the CBR+ National Steering Committee has resigned, and his replacement has not been found. Since an operational "rulebook" was developed during Mr Man Pak's selection as a replacement to the previous PEB member, it should be reviewed, and the IP provincial working group reconvened.

The collaboration between AIPP and the Programme was beneficial in that the IP in Myanmar and Viet Nam were able to organise and identify their priorities for engagement in REDD+. Since the collaboration ended in 2014, in Viet Nam, an Ethnic Minority Network, consisting of representatives from the 6 pilot provinces, has been established, partly to assist Mrs Truong in her role the EM PEB member, but also to ensure consistent participation in on-going provincial activities. Likewise, in Myanmar, the Ethnic Minorities/Nationalities Network has met and formed a core group of member organisations. This network's primary aim is to promote indigenous peoples' issues and knowledge. One of the thematic areas of focus is REDD+. Interestingly, the Myanmar Centre for Responsible Business has been in touch with POINT as they develop a Code of Conduct for the private sector to operate in IP areas.

# c) The Karen communities in Mueang An Village view their involvement in the pilot area for REDD+ in Thailand as means to prove their good stewardship of natural resources.

In 1990s, the village was part of the epicentre of conflict with the Royal Forest Department (RFD), Thailand. The villagers found themselves squatters in a newly designated National Park, facing allegations that they are causing deforestation through their shifting cultivation practices. When RFD later approach them with the proposal of a REDD+ pilot area, the villagers agreed, not based on potential results-based payments, but rather, through carbon measurement activities, to demonstrate their shifting cultivation practices were not causing deforestation. They also benefitted from acquiring technical knowledge as well as the rice mills, and crops that were introduced as part of alternative livelihoods. While the circumstances for Mueang An Village were extreme, the lesson here is not to immediately assume that villagers participate in REDD+ for monetary gains.
