9. Brief summary of the mission

9.a Background

Myanmar became a partner country of the UN-REDD Programme (Programme) in December 2011 and has quickly taken steps to start implementing REDD+ readiness activities. A *REDD+ Readiness Roadmap* was finalized in 2013, based on a multi-stakeholder dialogue and engagement process, with the participation of Government officials, civil society organisations, representatives from ethnic minorities, independent experts and international development practitioners. Since 2014, the Programme is providing some initial support to the implementation of the *Roadmap* through the so-called Targeted Support window. In 2015, Myanmar submitted a proposal to the UN-REDD Policy Board for a National Programme. The 15th meeting of the Policy Board approved Myanmar's funding request on a provisional basis, pending confirmation of additional contributions. In the meantime, the Programme Management Unit (PMU) is fully staffed now that the CTA is on board. The 3 Technical Working Groups (TWG): Drivers and Strategies; Stakeholder Engagement and Safeguards; and National Forest Monitoring System and Forest Reference Emission Levels/Reference Levels are operational.

9.b Main Findings

- The revision of stakeholder mapping and analysis is progressing slowly. Different tasks, methodologies, and intended outputs were
 clarified between the SE officer, the NP Coordinator and the regional SE specialist. In addition of an encompassing consultation and
 participation plan for the Programme, it was agreed that the officer will also develop a detailed plan for the development of the draft
 national REDD+ strategy by the end of 2016.
- To meet CO's procurement requirements in recruiting CSOs or NGOs to implement Programme activities, the decision was made to create a roster of organisations. Areas of required expertise have been identified, and a Request for Information will be issued. The PMU will then recruit a national consultant to assess the capacity of these organisations against a list prepared by CO.
- To move ahead with the recruitment of a NGO to facilitate the self-selection of the CSO and IP/Ethnic Minorities member, CO has
 agreed to proceed with a Reimbursable Loan Agreement modality. The successful individual representing the NGO is expected to be
 in place by end of March. In preparation for these workshops, Min Soe and Aung Kyi will work on introductory power point
 presentations.
- In preparation for the development of a national Stakeholder Engagement Guidelines for REDD+, the PMU and the regional SE specialist will have a joint discussion with the consultant to ensure common expectations related to the ToR, division of roles and responsibilities as well as identify dates for a mission. The team understood that while the guidelines will be quite generic, it should be anchored in a Burmese context. To ensure national ownership as well as comply with general expectations, a national consultation workshop will be organised for the near final product, in addition to the normal function of the TWG on Stakeholder Engagement and Safeguards.

- Based on remaining TS funds, and pending availability of funds for the NP, the work on legal and institutional capacity assessment of
 policies, laws and regulations would be divided, with the former prioritised for 2016 as the findings will help inform the development
 of the safeguards roadmap. Once the roadmap is available, and barring worst-case scenario for the NP, the latter will commence
 towards the end of 2016, followed closely by a scoping study of grievance redress mechanisms for REDD+.
- Official members of the 3 TWGs have been confirmed based on a list of line agencies and CSOs pre-identified during a workshop between the interim CTA, and these organisations in 2015. No designated alternates have been identified, but it was recognised that there should be good communication and continuity between the official members and their alternates.
- A World Bank representative was on mission in Myanmar with the aim of identifying opportunities for support, although the scope
 was largely undefined. Through the CO, the CTA provided information regarding the Programme. The regional specialist also shared
 a summary presentation of how specific steps in the country approach to safeguards overlap with FCPF's requirements for the
 Strategic Environmental and Social Assessment and its corresponding Environmental and Social Management Framework. This was
 extracted from a presentation prepared by Jen Laughlin for a safeguards workshop in Bhutan where FCPF is the delivery partner.
