10. Describe the financial, technical and/or advisory arrangements your organization has with the UN-REDD Programme, as well as the governments of the UN-REDD pilot countries, NGOs, or

private sector organizations as they pertain to the UN-REDD process.

ANS: Considering the fact that the UN-REDD Programme was established last year, July 8 2008 and formally launched September 24 2008, the process of effective working relationships between and among stakeholders is on-going.

Financing options considered include voluntary contributions from developed countries, bilateral or multilateral arrangements, Official Development Assistance (ODA), and establishment of Multi-Donor Trust Fund mechanism. The MDTF of the UN-REDD Programme is laudable as it allows for easy coordination among agencies and easy transfer of resources to developing countries. Moreso, certain percentage of revenues from CDM Trust Fund in each developing country should be set aside for driving UN-REDD Programme.

CCN Nigeria is working in partnership with the Nigerian Government on National REDD Programme and at the civil society level, it works with the relevant organizations in the Phase-One Pilot Countries – Democratic Republic of Congo, Tanzania and Zambia through PACJA.
