- International functions in support of national REDD+ readiness process -> AGENCY SUPPORT TO COUNTRIES
- Guidelines, technical advice, regional/international workshops, analyses, reviews, and backstopping of national programmes provided by the 3 UN agencies
- Includes Secretariat and Policy Board

  - Multiple Benefits
- Has launched 3 new work areas (funding by PB4):
  - Governance
  - Payments and benefit sharing
  - Transformational strategies



# **MRV and Monitoring**

- Backstopping of National Programmes
- Development of conceptual framework and technical guidance (following the strategy, i.e. robust systems that meet the requirements of C MRV, broader information needs for REDD+ policies, and monitoring of safeguards)
- Training to build capacity:
  - In collaboration with Brazil/INPE, GTZ, EPA, UNFCCC, CfRN and universities
- Convening space agencies and remote sensing initiatives towards standardized and available data
- 2<sup>nd</sup> workshop with Chatham House on monitoring governance

# Guidelines for Free, Prior and Informed Consent (FPIC)

GRAMME

0

- **Consultative process** with Indigenous Peoples and CSOs
  - Asia (June) and Latin America (October); Africa (January 2011)
  - Open for public review before finalization in mid 2011
- **Challenges**: scale & awareness on REDD+ benefits
- Results: Increased understanding of FPIC and shared views and expertise by stakeholders
- Advanced, in practice, the UN Human Rights Based Approach to Development Cooperation and UN Declaration of the Rights of Indigenous Peoples



## **Multiple Benefits**

OGRAMME

- Cambridge workshop on multiple benefits (April 2010)
  Identified priorities and need for safeguards
- CBD/UN-REDD workshop recommended how REDD+ contributes to the implementation of the CBD's work forest biodiversity
- Developing a framework for environmental safeguards
  - To identify globally relevant principles based on MEA & indicators and monitoring arrangements
  - Planning pilot testing in DRC

# Risk Assessment tool for Social Principles

OGRAMME

- To Improve program design and sustainability
  - To minimize the risk of adverse impacts and mitigate risk
  - To assist in prioritizing activities and managing resources
  - Identify best practice
- Matrix of YES/NO questions will indicate any potential risk areas related to good governance, livelihoods and policy coherence
- Where risks are identified, the tool recommends risk mitigation actions



#### Social and Environmental Principles & Risk Assessment Tool - Next Steps

OGRAMM

- Integrate environmental standards (Dec 2010-Jan 2011)
- Consult across UN-REDD partnership (Jan Mar 2011)
- Coordinate with FCPF (Jan Mar 2011)
- Pilot application of risk assessment tool (March June 2011)
- Public comment period (Aug Sept 2011)
- Finalize (end 2011)



### **Transformational Change**

• Study on financing of REDD+ projects commissioned, to compile project level experience from REDD+ projects to inform us of innovative opportunities for financing





## For Attention of the Board

GRAMME

- Two-year budget for the Secretariat will be submitted for intersessional decision in December
- Five-year framework for the new Global Programme is being drafted based on the UN-REDD Strategy, to be presented at PB6 as basis for future funding allocations
- Operationalize the Strategy
- Align the funding for secretariat and agency technical support
- Syncronize the Global Programme with calendar years
