## Memo on CSO Self Selection Process - Asia-Pacific Region

# **Background**

The CSO self-selection process for the UN-REDD Programme Policy Board (PB) has been carried out by independent CSOs at the global level up until now. The last two self-selection processes (2012 and 2014) were carried out by Bank Information Center (BIC) using an online voting process. In the 2014 process a joint self-selection process was undertaken for representatives to the UN-REDD PB and the FCPF Participants' Committee (PC).

The criteria and process for self-selection was developed by all the regional CSO representatives to UN-REDD PB and FCPF PC serving at that time. The process in 2014 resulted in the successful selection of representatives for all regions. BIC noted a number with the process. An independent review by CSO representatives from other regions confirmed the validity of the self-selection result, while highlighting room for improvement.

There are ongoing discussions between the current CSO representatives to UN-REDD PB and FCPF PC on how to improve this process for the next rotation of the CSO reps which is likely to happen in late 2016.

## Outcome of Discussions between Asia-Pacific National REDD+ CSO Representatives (7-8 May 2015)

As a result of discussions on the self-selection process, CSO representatives from the Asia-Pacific agreed the following:

- National CSO reps from UN-REDD Partner countries with National Programmes and PEBs are to form a Steering Committee that will develop ToRs and oversee regional CSO self-selection process.
- This Steering Committee will develop timeline and some clear deliverables
- New ToR for the self-selection process would be developed by the Steering Committee with agreed boundaries to the process:
  - what types of candidate are eligible
  - provisions for alternate representative [could set it up so that alternate will automatically serve for the next term to make a more efficient process]
  - dispute resolution process
  - deadline for submission of nominees for representatives
  - rotation rules
  - selection will be determined through consensus discussion or vote if there is no consensus
- Current regional CSO Rep to the UN-REDD PB to present Asia-Pacific ideas to other CSO reps during May 2015 UN-REDD 14<sup>th</sup> PB Meeting
- May organise another regional meeting before the selection process to discuss the process further (end 2015)

The above was agreed by the current UN-REDD CSO Programme Executive Board (PEB) representatives and other CSO participants from the Asia-Pacific Region (see listed below) at a regional meeting in Bangkok on 7 May 2015.
