


Overview of forests in Nigeria

- Forest & woodland surface: **96,043 km²** (10% of total land area).
- Forest diversity: lowland rainforests (“high forest”), fresh water & mangrove forests, savannah forests.
- **Cross River State:**
 - about 50% of Nigeria’s rainforest
 - high & unique biodiversity (endemism)
 - part of the Guinea forest ecosystem



Our forests are critical socio-economically !!

- Forest resources – 2.5% of national GDP
- Millions of Nigeria's rural poor rely on NTFPs, for both self consumption, income and local commerce.
 - Some forest communities in Cross River State derive as much as 70% of household income from NTFPs
 - 80% of households in Ekiti State rely on firewood for cooking
- High potential for eco-tourism



High rate of deforestation

- Forests, biodiversity and NTFPs are threatened.
- In 1978-1995, the forest/woodland cover declined from 23 to 15 million ha – *agricultural land increased by roughly the same amount.*
- Deforestation rate is 3.5% annually – *unfortunately one of the highest in the world.*

Drivers of deforestation

- The drivers of deforestation are known.
- There are direct and indirect causes, some related to field activities (e.g. farming, logging, fuel wood, poverty) and others to weak policy and institutional capacities.

REDD is perceived as a political and financial vector to address the drivers of deforestation successfully.



Nigeria is already working on REDD+

- Political commitment to REDD+
- Awareness on the extent and drivers of deforestation
- Forest policy reforms ongoing
- A two-track approach to REDD+ readiness
- Institutional basis for REDD+ established
- Various REDD-related activities ongoing
- A UN-REDD scoping mission successfully conducted

Political commitment to REDD+ in Nigeria

- Nigeria is a partner country of the **UN-REDD Programme** since 2009 and member of its **Policy Board**.
- **Cross River State** has been a champion state in forest conservation:
 - 20 years of forest conservation initiatives
 - a Governor's logging ban
 - a commitment to explore PES and REDD schemes
- Nigeria participated in the **Oslo high-level Conference on Climate & forests** (May 2010).
- Nigeria wishes to lead **ECOWAS** and its member countries into REDD+ negotiations and readiness (*Nigeria is the only UN-REDD country in West Africa*).

Forest policy reforms ongoing

- New **National Forest Policy** – it endorses stakeholder participation and community forest management.
- A **Presidential Initiative on Afforestation for Economic & Environmental Sustainability** – already ongoing, with a focus on promoting indigenous forest species, and a target of expanding the national forest cover by 25% in 10 years.
- Cross River State:
 - a Governor's **timber moratorium**
 - radical reform of its **Forestry Commission**
 - new state law supports community forestry & Carbon finance

All these (and other) reforms occur at a perfect time to nurture REDD+

Nigeria envisages a two-track approach to REDD+ readiness

- a national REDD+ process that addresses the core REDD+ readiness elements;
- a more intensive REDD+ process in **Cross River State**, to experiment and advance REDD+ readiness, inform the national process and provide best readiness practice for other interested states



Nigeria is organised for REDD+

National level



- **National Advisory Council on REDD+**, headed by the Federal Minister of Environment.
- **National Technical Committee on REDD+**, with members drawn from government, civil society, research institutions, forest-dependent communities and the media, among others.
- A **REDD+ Secretariat**, to provide leadership and coordination in REDD+ readiness, including oversight of the two-track approach.

Cross River State

- The State's **Forestry Commission** is a recognized champion of forest protection and REDD+.
- State's **REDD+ Technical Committee** established, including 3 subcommittees for legal, stakeholder and technical matters.

REDD-related activities at National level

- Ongoing mapping exercise: ***“Carbon, Biodiversity & Ecosystem Services: Exploring Co-benefits”*** (with UNEP-WCMC support, launched in Nagoya’s CBD COP-10).



- **“Preliminary Assessment of the REDD+ Context in Nigeria”**, commissioned by Ministry of Environment (>150 pages).
- Active and increasing engagement in **REDD+ negotiations** – Nigeria intends to become a leading REDD+ advocate in Africa & worldwide.

REDD-related activities in Cross River State

- 20 years of community-based forest conservation experiences.
- Linkages with regional & international NGOs (*e.g.* WCS, Katoomba group, NCRC/Ghana, ERM/London).
- Member of the international Governors' Forum on Climate & Forests
- REDD+ pilot sites identified, proposals are under development.
- Recent experience in community-based Carbon assessments.
- New state law recognises community forestry & Forest Management Committees (FMCs)



UN-REDD scoping mission

(October 2010)

- A UN-REDD team visited Nigeria and CRS, conducted field visits, met with governmental & non-governmental stakeholders, held participative workshops, and debriefed with the Federal Minister for Environment and the Governor of Cross River State.
- The mission noted a **high degree of political and stakeholder commitment for REDD+**, across different levels.
- The mission observed that **the basis to launch a robust REDD+ readiness process** are present.



UN-REDD scoping mission

(continuation)

- A **6-month REDD+ roadmap** will be implemented as interim arrangement, with UNDP financing, with a focus on:
 - capacity-building
 - stakeholder engagement
 - drafting a *REDD+ Readiness Plan*.
- The **REDD+ Readiness Plan** will be submitted to the next **UN-REDD Policy Board** to mobilise funds – *some US\$ 4 million would be ideal to back a 2-year readiness process*
(NOTE: Nigeria has no FCPF or other international support for REDD+).
- Nigeria wishes to express full confidence in the UN-REDD Programme and its team as a great partner for REDD+ readiness, with technical, financial and policy support roles alike.
