Global Programme - what is it?

- International functions in support of national REDD+ readiness process
- Guidelines, technical advice, regional/international workshops, analyses, reviews as well as backstopping of national programmes that the three UN agencies provide
 - ⇒ that support country action
 - ⇒ benefit more than one country and beyond pilot countries
 - ⇒ that support the UNFCCC process on a global scale
- Secretariat and Policy Board





Background and Status of Global Programme

1st Policy Board

- Endorsed global programme including an indicative work plan and budget of US\$6.7million (18 months, until June 2010)
 - MRV guidance
 - Stakeholder engagement
 - Analytical framework for multiple benefits
 - Knowledge management, coordination and communication

2nd Policy Board

- Reviewed the workplan
- Approved the first budget revision, adding funds to establish the secretariat, US\$2.9million (12 months, until June 2010)





Budget Revision – seeking approval of Policy Board

Activities - MRV

- Review of REDD+ monitoring activities to enhance coordination, including greenhouse gases and co-benefits and safeguards
- MRV workshops for capacity development
 - Global workshop (June 2010) share country experiences and present the current MRV framework, and regional workshops (Asia, Africa)
 - Carbon inventories workshop with IPCC experts
- Technical support to develop national monitoring systems & RELs
- Guidelines
- MRV backstopping team at FAO
 - One expert per regional group of countries & one expert for global functions
- Contribution by UNEP-WCMC





Activities – Stakeholder engagement

- Finalise the UN-REDD Guidelines on the Engagement of Indigenous Peoples and support their application
- Support participation of IP and CSO representatives in UN-REDD Programme and other meetings
- Enhance implementation of a recourse mechanism
- Facilitate IP & CSO engagement National Programmes through guidance, contacts with IP & CSO networks, consultation processes and sharing of results





Activities - Secretariat

- Organize Policy Board meetings (including travel support to member participants from developing countries)
- Further develop the UN-REDD programme, fund raising
- Strategic planning
- Build partnerships enhance collaboration
- Monitor and evaluate the UN-REDD Programme
