REDD+ SURVEY: LAO PEOPLE'S DEMOCRATIC REPUBLIC

Country background

According to the Forest Cover and Land Use Survey conducted by the Ministry of Agriculture and Forestry, the Current Forest (with canopy density higher than 20%) decreased to 9.8 million ha (41.5% of total land area) in 2002 from 11.2 million ha in 1992 with an average loss of 134,000 ha per annum equivalent to 0.6% of the total land area. Similarly, forest density has decreased dramatically with dense forest declining from 29% in 1992 to 8.2% in 2002 and open forest increasing from 16% to 24.5% of the total. The drivers of deforestation and forest degradation are 1) shifting cultivation by local farmers for both subsistent and commercial purposes, 2) large scale forest conversion to tree/agriculture crop plantations by investors, 3) illegal logging in many cases followed by conversion to crop production or slash and burn cultivation and 4) loss of forests to infrastructure mostly hydropower dams. It is estimated with several assumptions that annual emission from deforestation between 1992 and 2002 is 48.4 million tones CO2. The Forestry Department has oversight of Lao PDR REDD+ policy and developing a REDD mechanism in line with FCPF process and with bi-lateral donor supports.
