Participatory preparation<sup>8</sup> of the National REDD+ Strategy (ENAREDD+) has been ongoing since the presentation of Mexico's Vision on REDD+: Towards a National Strategy,<sup>9</sup> which contains key targets and definitions that guide the development of ENAREDD+ and by means of which the importance of the inclusion of public policies that favour sustainable rural development is emphasized, incorporating and enhancing community management of forests and conservation of their biodiversity. ENAREDD+ is aligned with the targets, objectives and strategic mitigation actions of the forest sector, which are included in the Climate Change Strategy.

ENAREDD+ aims to achieve the reduction of emissions from deforestation and forest degradation and to conserve and increase the forest carbon stocks within the framework of sustainable rural development for Mexico, with assurances that the safeguards and principles set out in the strategy and in the legal framework in effect will be applied and observed. In order to do so, the ENAREDD includes as an objective the development of a National Safeguards System (SNS) for respecting and addressing the safeguards established in the UNFCCC Cancun Agreements (Decision 1/CP.16), considering the provisions of Decision 12/CP.17 adopted in Durban in 2011, Articles 1 and 2 of the Mexican Constitution, and Article 134 bis of the LGDFS.

The consultation of the final draft of ENAREDD+ will be conducted in 2014 and 2015, mainly with financing of the FCPF readiness fund. Progress regarding the SNS includes two consultancies financed by the initiative Mexico Alliance for REDD+ (MREDD+). These had as general objective to present clear options and recommendations on how to implement a SNS for Mexico in a way that is country-led and building from the country's existing governance system (its legal, institutional and compliance frameworks), and to ensure the effective implementation of the UNFCCC REDD+ safeguards. This work included a review of the applicable national legal framework and the existing gaps, the analysis of multilateral initiatives and their relation to REDD+ safeguards and development of the conceptual framework for the design of the SNS in Mexico.

There has also been some progress analyzing the compliance and institutional frameworks, through a consultancy with funding from MREDD+<sup>10</sup>. The objectives of this consultancy include the identification, analysis and systematization of the reporting mechanisms and processes associated with national policy instruments that could be relevant for safeguards reporting; the preliminary development of structural indicators (based on the legal framework) for the report of REDD+ safeguards; and identification of the existing institutional arrangements that could support the safeguards information system.

Additionally, there have been some activities to pilot the Social and Environmental Standards (REDD+ SES) in Early Action Areas (Jalisco and Yucatan Peninsula). In Jalisco, in early 2013, there were dissemination and sensitization workshops about REDD+ Safeguards and REDD+ SES. In the Yucatan Peninsula there have been workshops so that relevant actors and stakeholders have more information about REDD+ Safeguards and REDD+ SES. A call for applications was launched in early 2014, and the process has begun to establish the standards committee of the Yucatan Peninsula.

  - a. How the relevant aspects of the legal framework will be utilised to operationalize the safeguards;
  - b. How the relevant aspects of the institutional framework will be utilised to guarantee the operationalization of the safeguards;
  - c. How will existing information and reporting systems be used to gather information on the safeguards implementation when implementing REDD+ activities,
  - d. How existing GRMs will be used to deal with grievances associated with the safeguards implementation (or lack of) when conducting REDD+ activities; and
  - e. How existing non-compliance aspects/mechanisms will be used to deal with any failure to address and respect the safeguards when implementing REDD+ activities.

In accordance with Article 3 of this decree and Article 17 of the General Sustainable Forest Development Law (LGDFS), CONAFOR is the federal agency responsible for developing, promoting and encouraging forest production, conservation, and restoration activities and for participating in the development of plans and programs and the application of the sustainable forest development policy. It therefore acts as the focal point for REDD+ preparation and implementation in Mexico.
