Why are the safeguards needed?

In reducing CO2 emissions by avoiding deforestation, REDD+ presents both **benefits** and **risks** to people and nature.



Safeguards are a key element to deliver high quality emissions reductions and to enable access to REDD+ financing and/or results-based payments



UNFCCC safeguards requirements

Countries promote & support the Cancun Safeguards throughout REDD+ implementation Safeguard information system (SIS) to provide information on how the country is addressing and respecting the Cancun safeguards



Country approaches to safeguards



Country approach to safeguards

Refers to the existing governance arrangements and processes – such as policies, laws, regulations and institutions – that countries can draw upon to respond to safeguards requirements for REDD+ aligning with national goals

Potential to provide a single, unified approach through which a country can accommodate the safeguards obligations of different initiatives, donors and investors


Each country will have its own particular approach to safeguards, reflecting unique needs and circumstances, range of socioeconomic issues and environmental concerns, including gender issues

Country approaches to safeguards are built through participatory and inclusive processes that engage key stakeholders UN-REDD Programme has developed a conceptual framework for country approaches to safeguards, based on three core elements:

- policies, laws and regulations
- institutional arrangements
- information systems and sources



Indicative elements of a country approach to safeguards




Safeguards Information Systems (SIS)

- System for providing information on how safeguards are being addressed or respected throughout the implementation of REDD+ activities
- General characteristics (UNFCCC decision 12/CP.17, paragraph 2):
 - Provide transparent and consistent information that is accessible by all relevant stakeholders and updated on regular basis
 - Be transparent and flexible to allow for improvements over time
 - Provide information on how all the safeguards are being addressed and respected
 - Be country-driven and be implemented at the national level
 - Build upon existing systems, as appropriate





Progress on safeguards information systems





Summaries of safeguards information

- Country reports on how the Cancun safeguards are being addressed and respected within the context of a national REDD+ strategy or action plan
- They should include information on the following (UNFCCC decision 12/CP.17):
 - REDD+ activity or activities being implemented
 - National circumstances relevant to addressing and respecting the safeguards
 - Description of each Cancun safeguard in accordance with national circumstances
 - Existing systems and processes
 - How each safeguard has been addressed and respected
 - Other relevant information
- Summaries of information are key tools for sharing information on safeguards and provide an opportunity for generating confidence in safeguards processes
